RESOLUTION NO. 1305

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HAMILTON, MONTANA ESTABLISHING A CITY OF HAMILTON ASSESSMENT FOR THE DOWNTOWN HAMILTON BUSINESS IMPROVEMENT DISTRICT FOR FISCAL YEAR 2017 (BUDGET YEAR 2016-2017) IN ACCORDANCE WITH EXISTING ORDINANCES AND STATE STATUTES.

WHEREAS, by Resolution No. 703 dated August 18, 1998, the City Council of the City of Hamilton created the Downtown Hamilton Business Improvement District; and

WHEREAS, by Resolution No. 1092 dated September 2, 2008, the City Council of the City of Hamilton reestablished the Downtown Hamilton Business Improvement District; and

WHEREAS, the Downtown Hamilton Business Improvement District has submitted to the City of Hamilton their annual work plan, financial budgets and assessment schedule for the Fiscal Year 2017.
