

**CITY OF HAMILTON  
RESOLUTION NO. 1309**

**A RESOLUTION SETTING AT THE FUND LEVEL THE TOTAL APPROPRIATION, PROPERTY TAXES AND ASSESSMENTS REQUIRED, AND THE TOTAL NON-TAX REVENUES FOR THE CITY OF HAMILTON, MONTANA, AS REQUIRED BY LAW (7-6-4030 M.C.A.), AND ADOPTION OF THE FINAL BUDGET AS SET FORTH FOR FISCAL YEAR 2017 (BUDGET YEAR 2016-2017).**

*WHEREAS*, on August 16, 2016, Resolution #1305, establishing an assessment for the Downtown Hamilton Business Improvement District was approved; and

*WHEREAS*, on August 16, 2016, Resolution #1307, establishing an assessment for the Hamilton Street Maintenance District was approved; and

*WHEREAS*, on August 16, 2016, Resolution #1308, levying special assessments for the Lighting Districts 10, 12, 13, 14, 15 & 16 was approved; and

*WHEREAS*, a public hearing was held on July 5, 2016 and Resolution #1302 adopting a preliminary budget for Fiscal Year 2017 was approved; and

*WHEREAS*, a public hearing was held and detailed budgets by fund were established on August 16, 2016, by the City Council of the City of Hamilton for the 2017 Fiscal Year; and

*WHEREAS*, in accordance with 7-4-4201 MCA, the council shall determine by resolution the salaries and compensation of elected and appointed city officers and all city employees.

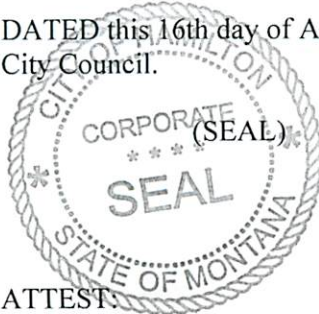
*BE IT RESOLVED*, that the annual appropriations, property taxes or assessments required, and the total non-tax revenues for the City of Hamilton for the 2017 Fiscal Year are set at the Fund Level as listed on the following attached schedules: Voted Levies; Non-Voted Levies; Non-Levied Funds.

*BE IT FURTHER RESOLVED*, that transfers within the same fund are authorized as provided by 7-6-4031(1) M.C.A. and transfers between funds are authorized as necessary for the execution of the final budget.

*BE IT FURTHER RESOLVED*, that the final expenditure and revenue budgets, attached hereto as Exhibit A, are adopted effective July 1, 2016.

*BE IT FURTHER RESOLVED*, that the budgeted salaries for all elected and appointed city officers and all city employees, attached hereto as Exhibit B, are adopted effective July 1, 2016.
